LETTER FROM BOARD

December 22, 2022

Dear Br. Alaa,

This letter constitutes an official notice from the AMLI Masjid Fatima Alzahra Board of Trustees. You have no legal right or position to communicate with AMLI as a Board of Trustee Masjid Fatima Alzahra member or any other position you might claim to have. Neither you nor any of the previous resigned members have any authority to hire or terminate members. We have received your written Resignation dated 9/18/2021, and it was effective from that date. When you requested to re-join the Board of Trustees as a member after you resigned, the Board of Trustee members discussed your request and set up some conditions for you to meet to approve you to re-join as a member based on AMLI procedure. However, you have failed to comply with the conditions which resulted in a declination to rejoin.

The Board of Trustees had informed you multiple times that you are no longer a Board of Trustee member, and you cannot join any of AMLI Board of Trustee meetings. You insisted to try to attend these meetings believing your resignation was reinstated. You interrupted AMLI Board of Trustee Meetings to the point that we have called Suffolk County Police to stop you from entering AMLI Board of Trustee meetings using force. AMLI has no other options now other than calling the Suffolk County Police Department to stop you from entering the Mosque and causing any damages to the Mosque or harassing the AMLI Board of Trustee members and worshippers.

One of the main reasons AMLI Board of Trustees declined your request to rejoin the Board of Trustees was your continuing problematic behaviors that includes spreading gossip and false rumors about AMLI board of trustees/ Treasurer.

Currently, you have formed an illegal Board of Trustees based on forged meeting minutes consisting of resigned members and non- members. Our former President- Mr. Mohamed Saeed confirmed that you illegally formed this board, forged minutes and documents to authorize a transfer of \$120,000 (one hundred twenty thousand Dollars) from AMLI public funds in the organization's official Citibank bank account. Mr. Saeed informed us he withdrew

the funds via certified check, created a new bank account, placed a resigned BOT AMLI member in this bank account, and gave the resigned BOT member full authorization to use this public fund (mainly coming from mosque donations). Mr. Saeed was asked to return the funds and was giving some time as good faith from AMLI Board of Trustees. Mr. Saeed failed to return the funds. He stated that he was following your instructions. His actions resulted in suspension from his position as an acting president of AMLI. All of his financial privileges associated with AMLI has been canceled. We ask you to return this money immediately to avoid any further legal ramifications from your illegal activities.

Your continuing problematic behavior caused a lot of harm and damage, and it is stopping us from doing our jobs to operate the Masjid. We advise you to stop immediately, to allow us to function and perform our duties.

We have been asking you to return the AMLI legal documents in your possession which you have failed to do. We had officially requested all of the AMLI documents in your possession to be returned through Mr. Mohamed Saeed when he was AMLI acting president before his suspension. Nothing was returned.

Please consider this letter as an official notice to notify you of the following: you do not represent AMLI, its administration, or its members. If you attempt to act as a representative of AMLI, this will be considered as a fraudulent activity. If you use or planning to use any of AMLI documents that you refused to return to the current administration with any other organization or a third party, the proper legal actions will be taken against you to stop your fraudulent behavior and activities.

If it is brought to our attention again that you are acting as an AMLI representative anywhere including social media or regular media or sharing this information with anyone from the public, the proper legal actions will be taken against you to protect the public from your misrepresentation, fraudulent activities, and behavior.
